## POLICY REMINDERS

### MHA GUEST POLICY

A resident may not have an overnight guest for over twenty-one (21) days in any twelve (12) month period

without MHA's written approval.

- Twenty-one (21) nights shall also be considered twenty-one (21) days if the guest(s) sleep during the day.
- If a guest violates the tenant's obligations in the lease, MHA may require the tenant to ensure that the individual involved will not be a guest.
- All residents who have a complaint regarding another resident's guest(s) should report said complaint to the MHA office IN WRITING.
- If the complaint involves a disruption of peaceful enjoyment or a threat to health or safety, contact the police immediately.

What if my debt has gone to collections?

A collector has to give you "validation information."

about the debt. They either have to do that during

the collector's first phone call with you or in writing

within five days after first contacting you.

The collector has to tell you:

- ✓ How much money you owe
- ✓ The name of the creditor you owe it to
- How to get the name of the original creditor, and
- ✓ What to do if you don't think it's your debt

Collectors can't harass you. For example, collectors

- ✓ Can't threaten to hurt you
- ✓ May not use obscene or profane language
- Can't repeatedly use the phone to annoy or harass you

Collectors can't lie. For example, collectors

- Cannot tell you that you owe a different amount than what you owe
- ✓ May not pretend to be an attorney or from the government
- Can't tell you that you'll be arrested or claim they'll take legal action against you if it's not true

### CARRYING CREDIT CARD DEBT?

Looking for ways to pay off credit card debt? Don't get scammed!

Offers to help you cut down or wipe out your debt might sound like a perfect solution, but dishonest debt relief companies will take your money and do little or nothing to help.

# So, how do you skip the scammers?

Spot scammy debt relief companies that make all kinds of promises to get your money upfront

Never pay anyone who tries to collect fees from you before they do anything to help you deal with your debt. That's illegal.

Don't share your financial or personal information with someone who calls unexpectedly to help you settle your debts. That's probably a scammer.

Don't do business with anyone who guarantees you results from a "new government program" for a fee or tries to enroll you without first reviewing your financial situation.

## **Neighborhood Connections**



Community is good, but isolation is unhealthy. Tenants tend to live within public housing developments. Housing can become a stage for


